

Scribes is excited to announce the publication of <u>The Scribes Manual</u> <u>for Law Review Editors</u>, edited by former Scribes president **Darby Dickerson**, who is the president and dean of the Southwestern Law School, and by long-time Scribes member **Brooke J. Bowman**, who is a law professor at the Stetson University College of

The manual is designed to be the definitive reference book for student-editors who work on law journals. The 19 chapters, written by law librarians and law

professors, will help student-editors "understand their roles and responsibilities and learn how their work fits within their law school's program of legal education."

Users will find information on the structure and organization of law reviews, the business side of law reviews, how to work with law librarians, common editorial positions, training for staff members, leadership styles, the editing process, author-editor relations, journal production and dissemination, postpublication considerations, copyright issues, and many other topics.

According to Mark E. Wojcik, a professor in the University of Illinois Chicago School of Law, "There hasn't been a book like this before, a book to help students understand and appreciate solicitation and editing of articles, leadership and operations of a law journal, academic and personal mentorship of editors and staff, and relationships with authors. . . . So if you're a law review editor or you aspire to be one, or if you're a faculty advisor to a law review, this is the book you've been waiting for."

Scribes Announces Law Review Award Winner


Starting in 1987, Scribes began an annual awards program recognizing exemplary student-written articles in law reviews and journals. This year's law review award winner is **Mona Alsaidi**, who wrote "Legally White, Effectively Othered: Recognizing and Investing

in Arab American Communities," 94 Temple L.Rev. 99 (2021). In the first part of 2021, Alsaidi was a legal intern at Legal Services NYC and the Office of Federal Operations. She then served as a legal intern for the U.S. Court of Appeals from August 2021 to April 2022.

Erwin Chemerinsky Wins 2022 Scribes Book Award

For more than six decades, Scribes has issued an award for the best legal-scholarship book published the previous year. Typically, 40–50 books are nominated annually, creating considerable competition. Therefore, the winning book and the honorable mentions are among the finest publications in terms of current legal scholarship.

This year's award winner is Erwin
Chemerinsky, who authored Presumed
Guilty: How the
Supreme Court
Empowered the Police and Subverted Civil
Rights. The book delves into how the Supreme
Court's rulings since the 1950s have enabled





discriminatory policing and have sanctioned excessive law enforcement. Presumed Guilty shows "that an approach to policing that continues to exalt 'Dirty Harry' can be transformed only by a robust court system committed to civil rights."

Chemerinksy is the dean and Jesse H. Choper Distinguished Professor of Law at the University of California's Berkeley School of Law.

Two honorable mentions were also selected:

- <u>Sexual Justice: Supporting Victims,</u>
 <u>Ensuring Due Process, and Resisting the</u>
 <u>Conservative Backlash</u>, by Alexandra
 Brodsky, a civil rights lawyer with Public Justice
- The Rule of Laws: A 4,000-Year Quest to Order the World, by Fernanda Pirie, a professor of the anthropology of law at the University of Oxford

Mark Cooney Receives Joseph Kimble Distinguished Service Award

Each year, the Joseph Kimble Distinguished Service Award is conferred upon an individual who has made remarkable contributions to Scribes and its work over time.



For 2022, Scribes has selected **Mark Cooney** as the award recipient. Cooney began his career in 1992 as a civil litigator. In 2003, he accepted a faculty position in the Thomas M. Cooley Law School, where he has taught courses such as Drafting, Research and

Writing, Scholarly Writing, and Advocacy. He has served as the chair of the school's Research and Writing Department since 2011.

Cooney was the editor in chief for The Scribes Journal of Legal Writing from 2013 until the start of this year and now is the senior editor. In 2018, he was the corecipient of the Center for Plain Language's ClearMark Award in the Legal Documents category.

Additionally, he has published 2 books and upwards of 40 articles on legal writing, law, and legal practice. He has shared his knowledge about writing through preparing tips that have been featured in the Scribes Tuesday Tip series and in the State Bar of Michigan's daily calendar.

Jillian L.
Schumacher, a partner at Daniels & Tredennick, won the Houston Young Lawyers Association's 2022 Woodrow B. Seals Outstanding Young Lawyer of Houston Award.



She also won the Texas Young Lawyers Association's 2022 Outstanding Young Lawyer of Texas Award. Schumacher has served as lead counsel in the Supreme Court of Texas, the U.S. Court of Appeals for the Fifth Circuit, and the U.S. Supreme Court. Prior to joining Daniels & Tredennick as an appellate lawyer, Schumacher spent several years as a law clerk in two appellate courts.

Schumacher has also served on the Houston Bar Association Appellate Council and as the editor in chief of the Appellate Lawyer. Further, she has spoken and written on various appellate topics, and her work has been presented in the State Bar of Texas's Advanced Civil Appellate Practice Course.
