## Key Tips to Increase Scribes' Reach

Scribes was established in 1953 with the goal of promoting clear, succinct, impactful legal writing. The society achieves this objective through a variety of efforts, including *The Scribes Journal of Legal Writing*, *The Scrivener* newsletter, CLE webinars and other professional development programs, and annual writing and service awards.

Scribes wants to increase its reach so it can benefit more legal writers. To do that, the society needs your help. Here are ways you can increase awareness of Scribes in the legal community:

- Become a [sustaining member or a life member](#).
- Talk to your **employer and your alma mater** about becoming [institutional members](#).
- Use Scribes [publications](#) in your work.
- Recommend that **outstanding colleagues join Scribes**. Lawyers who qualify to be [regular members](#) pay \$75 per year to receive all member benefits.
- Tell **law students and new lawyers** about Scribes and the professional development opportunities it provides. Student editors pay just \$15 per year, and lawyers who graduated fewer than five years ago pay just \$25 per year.
